

Privacy Policy

Thundermark Games Inc. (or “the Company”, or “we”, or “us” hereinafter) has adopted this Privacy Policy to explain how the Company collects, stores, and uses personal information collected in connection with the Company’s products and all services and websites related to them (together referred to as “Services” hereinafter). In short, we respect the privacy of users of our applications, but please take your time to read the information below to learn more.

Thundermark Games Inc. will only collect and process information about you in accordance with this Privacy Policy and applicable legislation.

Information we may collect from you

We may collect and process the following data about you:

- Information that you provide when you fill in forms while using the Services, such as your name, age, address, email address, sex and mobile number. We may also ask you for information when you purchase products (“Products”) from the site, register for our mailing list, access our chat forum and when you report a problem with the site.
- Information about you such as your name, address and contact details when you enter a competition or prize-draw Company may choose to operate.
- If you contact Thundermark Games Inc., we may keep a record of that correspondence.
- Company or Company’s agents on Company’s behalf may also ask you to complete surveys that we use for research purposes, although you do not have to respond to them.
- Details of any transactions you carry out while using the Services and of the fulfillment of your orders (“Orders”).
- Details of your visits to the site including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for Company’s own billing purposes or otherwise and the resources that you access.
- Non-personal data that does not directly make it possible to identify you, such as (i) device properties, including, but not limited to IP address, Media Access Control (“MAC”) address and unique device identifier or other persistent or non-persistent device identifier (“Device ID”); (ii) device software platform and firmware; (iii) mobile phone carrier; (iv) geographical data such as zip code, area code and coarse location; (v) game progress, time used playing, score and achievements; (vi) other non-personal data as reasonably required by Thundermark Games Inc. to enhance the Services by Thundermark Games Inc..

Usually we rely either on your consent, when specifically requested, or on our obligation to perform a contract with you in the course of providing our Services to have a valid legal basis to process your personal information. However, sometimes we may also rely on our legitimate interest to process some of your personal information for our marketing or other similar purposes.

Nevertheless, you can always withdraw your consent by leaving us a written notice at any time. Also, you may always object to our processing activities based on the legitimate interest and your data will be completely deleted from all our systems. If one of such actions happens we will stop to process your data.

Use of cookies

Cookies are small files, often including an anonymous unique identifier, that a site or its service provider transfers to your computer's hard drive through your web browser (if you allow). Cookies enable the sites or service providers' systems to recognize your browser and capture and remember certain information.

Cookies may be required to use the Services provided by Thundermark Games Inc.. We use cookies to understand and save your preferences for future visits, keep track of advertisements and compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools in the future.

Some third-party cookies are set by services that appear on the site. They are set by the operators of that service and are not in our control. For example, they are set by Twitter, Facebook, YouTube, Google+ and other third party services, and relate to the ability of users to share content on the site.

You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies.

Do we disclose any information to outside parties?

The Company does not sell, trade, or otherwise transfer to outside parties any information collected from you. This does not include our affiliates, subsidiaries or trusted third parties who assist us in conducting our business, operating our website, processing your data and providing the Services to you, as long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect rights, property, or safety of ours or of other parties.

Thundermark Games Inc. may use and disclose to its partners and contractors the collected non-personal data for purposes of analyzing usage of the Services, advertisement serving, managing and providing the Services and to further develop the Services.

The analytics companies, which provide their services to Thundermark Games Inc., may combine the collected information with other information they have independently collected from other services or products relating to your activities. These companies collect and use information under their own privacy policies.

Where do we process your data?

Your data will always comply with applicable legislation (e.g. GDPR, CCPA as may be applicable). Your data may be processed in the US, the EU and Ukraine.

What do we use your information for and how long?

Any of the information we collect from you may be used in one or more of the following ways:

- To ensure that content from the site is presented in the most effective manner for you and for your computer.
- To provide you with information, Products and/or Services that you request from us or which may interest you, where you have consented to be contacted for such purposes.
- To notify you about changes to our Services.
- To fulfill our legal obligations and respond to litigation.
- For our statistical or survey purposes to improve the site and communicate our Services to you.
- To prevent or detect fraud or abuses of the site and enable third parties to carry out technical, logistical or other functions on our behalf.
- If you consent, to notify you by email of our Products, promotions, competitions and special offers that may be of interest to you.
- To create non personally identifiable reports on the user interaction with the site.

We will delete your personally identifiable information when we have no need or a legal basis to process it.

Remember that you always can ask us to delete all the information about you.

Your rights

In accordance with the applicable legislation, you have the following rights:

5. The right to restrict processing
6. The right for data portability
7. The right to object
8. Your rights in relation to automated decision making and profiling
